

**ORDINANCE TO AMEND THE ZONING ORDINANCE OF THE
MUNICIPAL CODE OF THE
TOWN OF WAYNE, WASHINGTON COUNTY, WISCONSIN**

WHEREAS, a public hearing was duly held; and

WHEREAS, the Town Planning Commission recommended said zoning changes; now therefore

THE TOWN BOARD OF THE TOWN OF WAYNE, WASHINGTON COUNTY, WISCONSIN, DOES ORDAIN THAT THE TOWN ZONING ORDINANCE BE CHANGED IN THE FOLLOWING RESPECTS:

Section 1. SECTION 2.08:

2.08 Work in Right of Way Permit

1. Any work in the Town right of way requires a permit. This includes excavating, trenching, directional boring, or any other operation that the Town deems relevant.
2. The permit shall include:
 - a. Name of Utility being installed or maintained.
 - b. Contractor/s information.
 - c. Location/work area.
 - d. Type of work.
 - e. Time duration of work.
 - f. Traffic flow restrictions.
3. Restrictions
 - a. Asphalt shall not be cut without permission from a Town representative.
 - b. All disturbed areas shall be restored to the previous condition. If restoration is not carried out in a timely manner the Town will issue a notice stating the time frame the restoration must be completed. If restoration has not been completed in the time specified, fines or legal action may be imposed.
 - c. Any damage to Town property and private driveways and culverts will be the responsibility of the applicant to restore and repair to the previous condition.
 - d. The applicant shall notify the Town in a timely manner if traffic will be detoured or roadway lanes will be closed.
 - e. The applicant shall provide all necessary signage and personnel to control traffic safely.
 - f. Depth of utilities will be a minimum of 3 feet.
4. The applicant agrees to indemnify and hold harmless the Town, its employees, and its agents from any cost, claim, suit, liability and/or award which might come, be brought, or be assessed because of the issuance or exercise of this permit or because of any adverse effect upon any person or property which is attributed to the partially or entirely completed works of the applicant.

Section 2. Section 5.06:

5.06 Driveways

- C. Culverts on Town roads shall be installed according to the approved Town Driveway permit
- D. No concrete surface shall be allowed in the highway right of way on Town roads

except where a concrete curb has been installed as part of the roadway.


Section 3. Section 5.05:

5.05 Parking of Recreational Vehicles

D. The use of a travel trailer or motorhome on any parcel is limited to recreation only and shall be limited to 15 days in a calendar year.

Section 4. This Ordinance shall become effective the day after proof of posting the same in three (3) public places in the Town and has been filed and recorded by the Town Clerk.
