 - i. Proeber hearing took place on 9/8/2020. Have not heard anything from the town attorney.

- 8. New Business
 - a. Anderson (8186 Broadview Lane) proposed garage
 - i. Discussion and action It is being built in the street yard so a conditional use permit is needed. Will get that set up for the October 21st meeting.
 - b. Anderson (8186 Broadview Lane/8183 Broadview Lane) moving lot line
 - Discussion and action Owner of 8183 Broadview wants to extend lot line 20 feet using 20 feet of owner of 8186 Broadview property. 8183 Broadview is zoned A2 and 8186 Broadview is zoned R1. If you take some of 8186 Broadview property and add on to 8183 Broadview, it becomes zoned A2. This can be done. No restrictions.
 - c. Bartender application Crossroads Imogen Hastings
 - i. Discussion and action CCAP was done. Nothing found. **Motion**(Samann/Schulteis) to approve the bartender license. Motion carried.
 - d. Special Souvenirs License renewal
 - i. Discussion and action Haven't been open since January 2020. A 'For Sale' sign is on property. No license renewal.

 - Discussion and action They want to put 2 mobile homes on the property (mother/daughter). They want to tear down the existing home and build a new home but the mother would still live in the mobile home. There is an ordinance against having 2 homes on one property. An alternative would build a mother-in-law suite on the new home and remove both mobile homes. They also mentioned that they wouldn't build for a couple of years. Motion(Schulteis/Samann) to approve the 2 mobile homes on the property with a 5 year limit (starting January 2021 and ending January 2026) for the mobile homes being on the property. Removal of the mobile homes will occur in January 2026 or when occupancy of the new home is taken, whichever one is earlier. Motion carried.
